 The alleged father, XXXXX, is excluded as the biological father of the child named XXXXX. The alleged father lacks the genetic markers that must be contributed to the child by the biological father. The observed non-matching alleles are at the loci listed above with a PI equal to zero. Based on testing results obtained from analyses of 15 different DNA probes, the probability of paternity is 0.0%.
